# Laws on school attendance II

#### **Compulsary education act (1969)**


Defines obligations and responsibilities for

- Parents and children (5 16/18 years old)
- Head masters/school principals
- School attendance officers

### With regard to

- School enrollment
- Visiting school
- Exemptions





# Laws on school attendance III

### Two types of absence

#### 1) Unauthorised absence

- No school enrollment, no exemption
- School enrollment but absent without exemption

#### 2) Authorised absence

- No school enrollment, with exemption
- School enrollment but absent with exemption



### Laws on school attendance IV

### **Education participants register act (2019)**

- National database containing education data
- Managed by DUO an agency of the Ministry of Education
- Portal
- School enrollment and deregistration
- Reports on unauthorised absenteeism



# Laws on school attendance V

#### **Recording and reporting absenteeism**

- Obligation for schools to record absenteeism
- No guidelines on recording authorised absenteeism
- Guidelines on recording unauthorised absenteeism can be distracted from regulations on reporting unauthorised absenteeism
- Some guidelines are contradictory (reporting halfdays, clockhours, classhours)



# Laws on school attendance VI

### Reported forms of unauthorised absence

4 categories

- 16 hours in 4 consecutive school weeks
- Unauthorised absence of 1 month or more
- Luxury absence
- Other absence



# Laws on school attendance VII

### **Reports from communities**

Yearly reports on types of unauthorised absence and exemptions from communities to the Ministry of education.

# Data on school attendance and absence II

#### **Research findings**


- Inspectorate of education 2015-2016 Unsatisfactory compliance with the Compulsary Education Act
  27% primary school, 69 % special education schools
  11% secondary schools
  Most problematic: absence administration, reporting unauthorised absence and granting leave
- Roelofs et al. 2021
  less systematic recording in primary education compared to secondary education
  Suggest that school personnel in primary schools is hesitant to report absenteeism



# Data on school attendance and absence III

 Dullaert (2019), Lubberman et. al. (2019). Research on the approach of longterm absenteeism 'Thuiszittersaanpak'

Absence is very often reported too late to communities



# Data on school attendance and absence IV

#### **Experiences of communities with data noted by Ingrado**

- Communities are critical on the quality of data they receive
- Comparison between DUO data from schools and data from communities in 2018 showed huge differences
- Part of the communities are critical on the data they are asked to report to the Ministry of education in relation to the approach of longterm absenteeism.

 Little is known on whether and how schools analyze their data on absence and attendance

# Bill on reducing school absenteeism

- Aims at an unambigous reporting of absence
- Offers possibility for formulating requirements on the absence policy of schools
